WASHINGTONIn the largest recovery ever for U.S. workers, the Continental Can Co. has agreed to pay \$415 million to more than 3,000 former employees who were illegally deprived of pension benefits.

The settlement comes a year after U.S. District Judge H. Lee Sarokin found that the company had schemed to save vast amounts of money by firing workers just before they qualified for full benefitsa violation of the Employee Retirement Income Security Act. Jakub v. Continental Group, 8949009.

Judge Sarokin named Yale Law School Prof. George L. Priest special master to help settle the claims, and after an intense week of head-knocking just before Christmas he succeeded in forging an agreement. One of the key plaintiffs' lawyers, John Jacobs of Chicago's Plotkin & Jacobs, said an additional incentive for settlement was the scheduled April 9 trial of civil racketeering allegations against the company, which could have resulted in treble damages and attorney fees.

The litigation began in 1981 under then-union staff attorney Daniel McIntyre, now a sole practitioner in Falmouth, Maine. Roslyn Litman of Pittsburgh's Litman, Litman, Harris, Brown & Watzman led the case through one trial; Michael Gottesman of Washington, D.C.'s Bredhof & Kaiser handled the successful appeal.
