In the story on page 1 of the Tuesday, Feb. 13 edition with the headline Seidel Gonda merges into Drinker, the correct number of active trademarks handled by lawyers at both firms is 20,000, not 2,000. And Drinker Biddle & Reath's offices are located at 1 Logan Square, not 2 Logan Square.

The story on page WP14 of the Women in the Profession supplement to the February 14 edition with the headline More Women Knocking at the Door, But Few Found in Positions of Power incorrectly stated that statistics compiled about the percentage of women attorneys, partners and associates were an average from the state's top 100 law firms. The information only includes statistics compiled from the 48 firms who chose to respond to the survey.

In separate stories in the Women in the Profession supplement to the February 14 edition, it was incorrectly reported that Joy Flowers Conti was the first female president of the Allegheney Bar Association. She was actually the second. Roslyn Litman, currently of Litman Litman Harris & Brown in Pittsburgh, was the first.
